






WHO WE ARE?



Overall 15593 children 7790 boys and 7803 girls received psychosocial support, Covid-19 awareness, CP, Hygiene training and child rights. 69 community based structures were established in CB CFSs with total of 1280 members (690 men & 690 women) on gender equality. 35 deportee children (under 18 age) reunified with their families who were deported from Pakistan. 75 most vulnerable children (10 girls & 65 boys) families received IGA assistance. Three-days training on CPER, PSS, CPiE, and community dialogue (CD) has been conducted by UNICEF and OHW to 92 (35 females and 57 male) CP actors in east region which included members from CPAN, DCPAN, NGOs, governmental CP units and project staff. Likewise, at the beginning of the project a training on CPiE, PSS, CFS management and referral mechanism has been conducted the CPER project staff by UNICEF representatives and then the same training was delivered and conducted to 200 CB CFS volunteers (99 female) by OHW. Also 3221 men and 3780 women from inside the community received the same awareness. During the project period, OHW with the financial assistance of UNICEF conducted numbers of awareness and training sessions for community people in which 4062 people (2052 male & 2010 female) have been sensitized on CP, hygiene and covid-19 awareness, child rights, girl's education, early child marriage, illegal migration, polio, MRE and positive parenting. In addition, during COVID-19, the CPER project staff delivered the same services to children and their parents' house by house based on protection measurements to ensure health and hygiene and protect them from the pandemic So, CPER project staff distributed 66625 soaps and other preventive material to CFSs Children and community members and 880 children (504 boys & 376 girls) referred to public hospital who had common disease and were suspected on COVID 19 cases.

Unconditional Seasonal Support Food Emergency Project in Balkh Province




Overall 1359.550 MTs were distributed on 10850 HHs have received the seasonal support food package consisting of wheat flour, vegetable oil, pulse and salt. According to project proposal, OHW implemented the seasonal support project in accordance with the close coordination of WFP and relevant stakeholders, the project was implemented in Kholum & Marmol Charbolak, Balkh, Sholgara, Keshendeh, Dehdadi, Kaldar and Dawlatabad districts for three months. The mentioned HHs food security got enhanced and their children nutrition was also secured and the HHs were appreciating the OHW for the implementation of such imperative project.

Women economic empowerment and food security project designed to target 3750 people with direct and tangible services to improve their livelihood, income generation and eating habits in rural areas of Samangan province. Meanwhile it will benefit 63000 people indirectly. The project participants are selected among the most deprived women of the 50 target CDCs (10 in Samangan, 10 in Herat, and 30 in Jawzjan) with the help of a set of criteria and jointly with departments of the ministries, members of the CDCs, local authorities and provincial and partner organisations.

The main objectives accomplished are.

- Women have employable skills for productive employment and benefit from enterprise development services.
- Women and men have improved their eating habits; the capacities of the partner organization have been improved.

Emergency WASH Response Project in Ghor Province




Winterization Support to Most Vulnerable Communities in Balkh, Kunduz, Bamyan & Kabul Provinces

As per the project activity plan and to better and well manage the project activities, accountability and transparency in the cash distribution of winterization assistance to most vulnerable 1120 HHs. OHW paid them Cash through mobile money system and did the biometric registration process for the selected beneficiaries which contracted with the was AWCC/Mobile money team. Moreover, the targeted areas of the project were Kunduz capital, Imam Sahib and Aliabad Yakablan#1 districts. and Shebar districts of Bamyan province and Shorgarah, Dawlatabad and Dihdadi districts of Balkh Province. Furthermore, the same winterization project was implemented in Kabul Shadab Zafar, Diwan Begy, Proja e Taimani District #2 and #5 for the IDPs. Returnees and Host Communities and have managed the implementation of projects effectively and on timely manner.

Improved food and nutritional security and increase the economic asset and strengthen their engagement in influencing decision making, policies and services and worked with community men and women using a Human Rights Based Approach, which focused on empowerment, strengthening community-based organizing structures and meaningful engagement by women. Through this project. In Balkh Dawlat Abad District, the OHW supported the women economic empowerment through installing the soap making group, Dawlat Abad REALISE team distributed 2580 KG saffron bulb and 9 KG Vatavax medicine for treatment of Saffron, including this OHW distributed Saffron seeds and its tools kits for six male led farmers of demo plot. In Balkh Kaldar District. OHW supported women through providing dairy group chiller, Zarranj, date printing machine for 2000 yogurt cans, milk boiling machine and 20 man led farmers received the seeds wheat cultivation and usage training.









COVID-19 Prevention Project in Balkh, Kabul & Kandahar

Enhanced community engagement and sensitization through awareness-raising on the prevention and spread of the disease in different districts of the target provinces including Kandahar and Balkh, disseminated soap and Information, Education and Communication (IEC) material conveying messages on the prevention and spread of COVID-19 to families in the target area, supported the Mo diagnostic centers through recruitment technical staff and provision of testing facilities Polymerase chain including two stand reaction (PCR) mach s, testing kits and and referred consumables. registered suspected cases of COVID-19 to the national surveillance system. COVID-19 project was very important and vital program, because Balkh and Kardahar Public Health Deportments didn't have the capacity to response the COVID-19 suspected people in term of registration, diagnose and awareness, through this program 3 technical staff hired to support Balkh public health deportment COVID-19 laboratory and three more 3 technical staff hired to support Kandahar public health deportment COVID-19 laboratory, the awareness rising messages were broadcasted through loud speakers the districts which are targeted for Kandahar province were Spin Boldak, Daman, Dand and Arghandab districts, the most significate result of awareness is that people have learned about the symptoms of COVID-19 virus.












Vocational Skills on Baluchi Embroidery in Nimroz


OHW implemented Vocational Training Center (VTCs-Baluchi Embroidery) funded by UNHCR under CBP project in Nimroz province. A total of 50 women were trained for six months in Baluchi embroidery skill in Zarranj Nimroz Province. The main purpose of this project was to provide returnees women which had a bad living condition and had the responsibility of their families (HOH) so for this purpose the OHW implemented the project with skill that will enable and empower them to find sustainable livelihood opportunities and generate income through their new learned skill to support themselves and their families.






Vocational Training on Tailoring in Kandahar Province







UNHCR under CBP project in Kandahar province, a total of 50 vulnerable IDP, returnee and host community women, were selected and provided eight months tailoring skilled through professional master trainer and other trainers, the main purpose of this project was to enhance the capacity of beneficiaries in order to make them enabled and empowered to find sustainable livelihood opportunities and generate income through their new learned skills to support themselves and their families. In addition, all the beneficiaries received different sessions such as literacy Gender Base Violence awareness. (GBV), children rights, wash awareness and basic awareness about business during this project period.

Infrastructure Activities

Construction of new building of Shaheed Azimullah Girls High School in Loy Wala Kandahar Capital.

OHW constructed Shaheed Azimullah Girls High school building having 8 rooms in two floors. this school was assessed and surveyed during the joint assessment in April 2019 UNHCR, OHW, by PRRD, DoRR, APA and Department of Education, Loy Wala is very large area in Kandahar capital with so much population of IDPs from south and southwest regions and returnees came from Pakistan too. Totally, 1549 students including 49 teachers are benefited from the school







Windows and Doors Repairing in Soof Primary School

The Provision of Primary Health care to Internally Displaced Persons in Kabul Informal Settlements (PHS/KIS) Afghanistan

> OHW is implementing Basic Package of Health Services project under Primary Health Services to IDPs Population in Kabul Informal Settlements in Kabul province and is operating through 5, Health Facilities (HFs) (2 static clinic and 3 mobile clinic), a at least two female staff are working in each facility. OHW have found the need of the vulnerable population that the mortality and morbidity of the KIS/ IDPs were high and huge number of people have migrated from their own place and province to migrate and settled in Kabul province due to armed conflict and natural disaster, economic problem in their own provinces. Majority of the population have moved to Kabul city due to conflict in war in their own places. Moreover, huge number of families are living in the very crowded and congested houses, poor sanitization facilities, low level for basic giene, increase risk of the communicable eases, lack of nutrition and increase nortality and morbidity of the women and children due communicable diseases and low vaccine courage .Until April 2017 the IDPs received medical services by SHRO organization, the population did not have access anymore and the population is not generally have access to the health services. Men and women involved in the designing and implementation of the project, in every health facility at least 2 women were

Fatima's Child Marriage was canceled through the Afghan Women Leadership Initiative AWLI

atima is seven-year-old girl, she has the aspiration to get educated and have happy life with her all brothers and sisters, but unfortunately due to the child marriage bad tradition, she was given to Mohammad's 17-year-old son. As The Afghan Women Leadership Initiative project work for the strengthening the leadership and active engagement in the community, the OHW office was notified through the community people that a seven-year-old girls is engaged to 17-year-old boy. The OHW took measure and invite Fatima's father Mr. Abdul Qodos to take part in the women leadership and strengthening workshop and awareness session and Mr. Qodos learned very much knowledge about women rights in Islam and Afghanistan constitution. After few days, Mr. Qodos invited OHW staff to his house and was regret on his decision.

OHW thanked Mr. Qodos having shared the issue and explained the entire process of engagement in the light of Islam and emphasized that without the acceptance of any side either boy or girl, the engagement will not be taken place and whoever did such sin, he or she would have committed the biggest sin and will have nothing to reply in front God Almighty. After listening the statements, Mr. Qodos thanked OHW for the implementation of Afghan Women Leadership Initiative project and he decided to cancel the child marriage of Fatima and will admit her into a near school to get education.

Abas is 7 years old admitted to the CFS center and enjoy learning much things with his more classmates

bas belongs to a poor family; his father is a labor and every day he erns money on which he only buys the food for one time for his family. During the visit, the hygiene educator found him in a very bad condition in terms of his personal hygiene. While the hygiene educator completed his checkup, it was found that Abas was suffering from

diarrhea, eye pain and secretion of tear. So, the OHW team took him to Child Friendly Space or CFS to learn the personal hygiene and took him to the near hospital for remedy. Time was running, the health educator visited Abas to see his personal hygiene and checkup his illnesses. Moreover, Abas and his family members were practically trained about self-hygiene like hand washing with soap, nail cutting, oral hygiene, foot hygiene, hair care, cloths and so on.

Conclusively, through Child Protection Emergency Response – CPER it means practically that Abas's clothes were clean, the nails were cut, hand and face were clean, and his personal hygiene was totally perfect and also the diseases that were caused to the child due to his poor personal hygiene were not observed. Fortunately, it was found that Abas and his family followed all instruction and advices which CPER project hygiene team had shared with them regarding their personal and environmental hygiene.

Asma 12 year's old harmful street working child started education through OHW social organizer.

Asma a 12 years old girl from Maimana city of Faryab province, she а street is child, working her mother bakes bread and she was a bread seller in the city area of Maimana. carrying heavy weight of bread for a very small profitable amount of money. Asma says she works most of days till 07:30 PM and earns



days till 07:30 PM and earns Asma is learning from the social organizaer and feeling happy from OHW assistances an insufficient amount of profit (100-150 AFG) a day.

Asma says "I met a social organizer from OHW, this lady stopped me and started asking me some questions, like why I was doing this harmful work being an under aged and a child who should play and study. Earning a chance, I shared the whole story of this difficult and bitter life. Social worker first gently asked me for sharing my personal information with her and then collected some important personal information in a form. The following day, the OHW social worker came to our area and talked to my father. She guided and gave awareness to my father about the harm and consequences of this harmful work and invited my father to fatherhood training. When my father participated in fatherhood training and he get aware of the convention of child right and the low on protection for child rights, he totally changed. My father thanked the OHW social worker and allowed me to join the Community children center (CCC).



Fariba 14 years old girl, established awareness raising class for other children of her village regarding CR, CP, CSG.

ariba is the School Student Council SSC member in Besh Oyleg Girls High School, she joined the SSC group on October 19, 2020, Fariba belongs to a poor family and having economic problems, her father and brothers are also jobless. She decided to deliver what she has learnt in the SSC, she started a tuition class in which she is teaching to 25 children of her village with an idea of change about the situation of children in her village. She started to encourage other children to participate in the protection of child rights and child protection in her village, she is participating in every decision being taken regarding children with the support of other children in the area, she is raising her voice against early marriage of children and encouraging children to go school and become educated. Moreover, she is delivering the child rights policy to society and stands against the pressure being faced to children and supporting Do No Harm policy for the children, she changes the mentality of many families who were forcing their boys and girl to early marriage, she stands against the fathers who were not allowing their girls to go school and convincing the parents through community elders, Olama and educated figures like school and university teachers, she stopped the children from working on the streets and doing harmful works and encouraged to enrolled them to schools by changing the mentality of their family on child labor.

OHW-FRB to visited from the class and see the changes which have come, when social organizer visited, there were 22 children present in her class and all the children were very active in session deliveries and identification of child cases and delivering child cases to community based child protection networks (CBCPNs). Conclusively, the people of the village especially fathers were very happy of the activities and services being delivered by Fariba, all they were very happy and thankful of Fariba that she has changed their viewpoint and mentality among children and acknowledging them of the right which children have.



Khaleda's Child Marriage was canceled through the School Students Councils (SSCs) member Yalda a 16 years old

haleda a 16 years old girl, she has the aspiration to get educated and have happy life with her all brothers and sisters, but unfortunately due to the child marriage bad tradition, she was given to underage marriage. The OHW office was notified through the School Students Councils (SSCs) member Yalda that a 16 year's old girl, Khaleda daughter of Mohammad Rahim who has been forced to early marriage by her father forced her to leave school and her further studies after getting engaged. The OHW took measure and invited Khaleda's father Mr. Mohammad Rahim to take part in the fatherhood training and give him awareness session of the bad effects of child marriage and Mr. Mohammad Rahim learned very much knowledge about child rights in Islam and Afghanistan constitution.

The result of the conducted training was: The father of Khaleda got information about all the rights of the children and give the permission to continue her education and go to school, after some days the child protection team visited from the house and family members of the child and all they were very happy and thankful of the coming of this project in their village and changing their idea and mentality on the rights of children. Conclusively, OHW thanked Mr. Mohammad Rahim having shared the issue and explained the entire process of engagement in the light of Islam and emphasized that without the acceptance of any side either boy or girl, the engagement will not be taken place and whoever did such sin, he or she would have committed the biggest sin and will have nothing to reply in front of God Almighty. After listening the statements, Mr. Mohammad Rahim thanked OHW for the implementation Yalda the member of SSC and he decided to cancel the child marriage of Khaleda and will admit her into a near school to get education.

Firoza a 13 years old girl, showed courage and stopped her early marriage by having the knowledge of her rights.

iroza a 13 years old girl lives in a poor family in Khan Aqa village of Pashtoonkoot district with two sisters, one brother and a mother she at the very younger age leads her family by weaving carpets she is a house headed child her two sister and one brother is younger than her and her mother is very weak she lost her father a few years ago



because of sickness. In a very younger age she has to support her mother, brother and sisters besides she is studying in Charmgar secondary school in grade six and successfully she is an active member of Children Groups.

She is very interested and motivated to participate in the activities of Children Group meetings and trainings held by OHW/SCI in Pashtoonkoot district and our team observed her very active in the Children groups she learned much on Child Rights and Child Protection and started to transfer the learnings to others in School, Community and home. As she is living in a poor family once a day her mother started thinking of to give her 13 years old girl Firoza to early marriage and remove her poverty because Firoza is the only one who weaves carpets and earns some money to feed her mother, Sisters, and brother she does her best but as she is very young she could not make it a lot besides she studies in school and is a member of Children Groups so her mother decided that the only way to remove her financial issues is to let her 13 years old child to get married. when the proposed family came and they were discussing about the engagement she suddenly appeared in front of them and said that I am a 13 years old child, I have my rights and I am so young, I can't get engaged until I am 18 years old, so kindly please go and leave us alone this is my right and I don't want to get married now. Then the proposed family leaved her home and she showed her believe on herself and her right that she has been learning it in the meetings and trainings held by OHW/SCI.
